A breeding certificate must be purchased for all pregnant mares by 01.10.2026;

The mating certificate will only be issued once all invoices have been paid.

! WARNING: no doses will be sent until the transfer for the stud service has been made and is effective!

The stud service is sold with a Live Foal Guarantee, which only applies if the mare aborts or her foal dies within 48 hours of foaling*. You will benefit from a postponement of the stud service to the following year.

* Subject to the mare being up-to-date on her vaccinations (Influenza, Tetanus & Rhinopneumonitis) and after receipt of a veterinary certificate. **The balance is non-refundable/the carryover is understood to exclude insemination and delivery costs for one year N+1 from the date of mating. Any unused carryovers will be forfeited.

A/ Mounting Type:

For the 2026 breeding season, the stallion is available for Hand Covering / Fresh Semen / Transported Chilled Semen only.

B/ Order for frozen semen:

Sending frozen semen straws is not automatic!

It is done on order from the seller by email: yeguada7sietereinos@gmail.com before the mare arrives at the insemination center.

This contract entitles the holder to the provision of glitter, not to a purchase.

Unused sequins remain the property of the seller.

C/ Embryo transfer:

This contract is valid for a single foal. In the event of embryo transfer, the buyer agrees to inform the seller of the number of embryos re-implanted into surrogate mares, and the buyer will be required to pay a stud fee corresponding to the type of breeding chosen in this contract per foal born.

(either €900 excluding VAT for PRE, or €600 excluding VAT for OC)

D/ Mating certificate / birth declaration:

The mating cards in Verified Origin are made via the IFCE – SIRE.

The mating cards in PRE are carried out via the ANCCE - AECE.

These will be issued by the seller. **The seller agrees to forward the mating declaration upon payment of all invoices.**

The buyer agrees to declare the birth of the foal within 48 hours.

The seller reserves the right to block the issuance of the birth certificate in the event of unpaid invoices from the buyer. Products are eligible for registration with the SIRE (French National Register of Animals) and with the AECE (French Association of Animal Breeders) for PRE (Preferred Animals).

Registration with SIRE is automatic, once the declaration invoices have been paid to IFCE and AECE (ANCCE).

SPECIAL CONDITIONS:

- ÿ The buyer declares to be aware of the conditions under which inseminations with semen are carried out.
Frozen semen. He will enter into a separate agreement with the insemination center for the boarding of his mare, and under no circumstances can the seller be held responsible for any damage that may occur to the buyer's mare.
- ÿ The costs of placement, insemination, boarding, gynecological follow-up, and any analyses are not included in the contract and are the responsibility of the buyer.
- ÿ We strongly advise our buyers to have their mares tested at a minimum for contagious metritis (AI).
This remains optional, however the disease seriously influences the success rate of a pregnancy.
