### ! PLEASE NOTE:

**No dose will be sent until the transfer for the breeding has been made and effective!**

The covering is sold with a Live Foal Guarantee, this only applies in cases where the mare aborts or her foal dies within 48hours of giving birth\*. You will benefit from a postponement of the breeding the following year.

\* Subject to the mare being up-to-date on her vaccinations (Influenza, Tetanus & RhinoPneumonitis) and after receipt of a veterinary certificate. \*\*The balance is non-refundable / the report excludes insemination and shipping costs for one year (N+1) from the date of mating. All unused reports will be forfeited.

## TERMS OF USE :

### A/ Type of covering:

For 2026 breeding season, the stallion is available by covering in hand, fresh or frozen semen.

### B/ Order for frozen semen:

The shipping of the frozen semen is not automatic! It must be ordered from the seller by email:

[yegualossietereinos@gmail.com](mailto:yegualossietereinos@gmail.com) before the mare arrives at the insemination center.

This contract entitles you to the provisions of semen, not a purchase. Unused semen remain the property of the seller. We always send 2 doses (each contain 8 straws) per mare. More necessary frozen semen dose can be booked, price is 40 euros each dose.

### C/ Embryo transfer:

This contract is valid for a single foal. In the event of embryo transfer, the buyer agrees to inform the seller of the number of embryos re-implanted in surrogate mares and the buyer must pay a stud fee corresponding to the type of breeding chosen in this contract per foal born (900€ excl VAT for a PRE, or 600€ excl VAT for others breeds).

### D/ Breeding certificate / Birth certificate:

The Breeding certificate for others breed are performed by IFCE – SIRE.

The Breeding certificate for PRE are performed by ANCCE - AECE.

The buyer agrees to declare the covering to the seller within 48 hours.

These are made by the seller. **The seller agrees to forward the breeding certificate upon payment of all invoices.**

The buyer agrees to declare the birth of the foal within 48 hours.

The seller reserves the right to block the issuance of the births certificates if the buyer has unpaid invoices.

Products can be registered with the ANCCE.

## SPECIAL CONDITIONS:

- ❖ The buyer acknowledges being aware of the conditions under which inseminations with frozen semen are carried out. They will enter into a separate agreement with the insemination center regarding the boarding of their mare, and under no circumstance can the seller be held responsible for any damage that may occur to the buyer's mare.
- ❖ The costs of placement, insemination, boarding, gynecological follow-up and any analyses are not included in the contract and are the responsibility of the buyer.
- ❖ We strongly advise our buyers to have their mares tested for at least contagious metritis (AI). This remains optional; however, the disease significantly impacts the success rate of a pregnancy.
- ❖ The stud service request will be validated upon receipt of this signed contract and full payment for the stud service and technical fees. This contract is valid for the 2026 breeding season, for insemination in France, Europe and others countries.
- ❖ Prices are shown excluding and including taxes. Taxes is applicable to stud services and is recoverable by professionals.
